* Achievements

1. Ensuring Access to WASH facilities at the community Level.

Ensuring Accessibility of potable water and sanitation door-to-door in the rural areas of poor and excluded tribal women and children by creating an enabling environment and removing constraints in the functioning of PRIs and VWSC at the village level. It helps towards rural living standards in schools for children and remote pockets of tribal families. The successful piloting of "SWACHH BHARAT MISSION" in rural areas of Deoghar, Jamtara and Pakur is being scaled up to neighbouring locations of the panchayats and villages covered, We are initiating innovative solutions for universal access to water and sanitation, focusing on efficient and equitable delivery of basic services especially to schedule tribes and schedule caste in the target area habitation. We have facilitated particularly Gram Panchayat Leaders and Jal Sahiyas for rapid intervention to construct toilets for each and every household with the prime focus of better safe utilization, technically sound, build capacities and skills to handle the WASH infrastructure as well as funds and submission of utilization certificates.

We ensure 15681 households' toilet construction as well as utilization of toilets to benefit 47043 persons.

We have set out access for toilets and hand pumps for 976 schools and AWCs which has brought about benefits to 39040 schools and AWCs children also ascertained safe drinking water to 808300 persons by repairing 6148 HPs & installing new 405 HPs. The above milestones are being achieved by 1380 skilled manpower towards WASH accessibilities.

- 2. Ensuring the promotion of second cropping in an additional area of 1348 acres of 2200 households.
- 3. Ensure income generation by fruit Orchids constituting mango, cashew nut, papaya, guava, etc, in 600 hectares of land of marginal farmers, reaping additional income of Rs. 12000 20000.
- 4. We have promoted land and water management in rural tribal areas of marginalized farmers to make possible optimum utilization.
 - i) Contour Bunding 230 acres
 - ii) Land Reclamation 367 acres
 - iii) Lift Irrigation 45
 - iv) Water Harvesting Tank 137
 - v) Shallow Wells (Chuan) 29
 - vi) Sericulture Development 500 farmers
- 5. Under women's development prospects, we have achieved and attained a strengthening of 175 SHGs. Besides this there have been credit linkages to 105 SHGs and 145 SHGs were annealed to the PANCHSUTRA LEVEL. Not only there has been a promotion of 2000 mahila kisan but also women SHGs have a collective savings of 2.13 crore consequently 97-98 % repayment of the loan.
- 6. 1250 farmers have been skilled in advanced agriculture practice.

7. 2898 demand generation of work with Job Card distribution out of which 2533 comprises in realization of work.

8. Training cum awareness on Rh incompatibility supported by Conexus foundation There have been conducted training cum awareness program on Rh incompatibility (Blood Group) in Jamtara district of Jharkhand among 2278 Health Frontline workers. It is observed that only 13% of them knew their blood group and only 0.69% were about Rh incompatibility. After the training and awareness, it is found that 46% of them know their blood group and 86% of them are aware of Rh Incompatibility. They spread the awareness so 62% of pregnant women know their blood group and 94% of pregnant women are aware of Rh Incompatibility.

9. Solar Irrigation Facilitation Program

Our team has facilitated and mobilized the farmers of Deoghar and Jamtara for installation and utilization of solar irrigation pumps set in 90% subsidy supported by the Switch On foundation. And so 287 application forms of woman farmers have been raised and submitted to the DAO's installations of the solar irrigation Pump-set are in process.

10. Nutrition improvement

Vitamin Angels is a program that focuses on improving the health of vulnerable populations, with a particular emphasis on women and children. They provide essential vitamins and minerals to at-risk pregnant women, new mothers, and children under five in underserved communities. These populations often face nutritional deficiencies that can hinder their growth and development and increase the risk of mortality.

11. Pre-School Nutrition and Education Initiative

This initiative strives to combat malnutrition and promote early childhood education for children aged 6 months to 5 years in Northern Indian villages. Utilizing Anganwadis, spaces like NGO centres, or community buildings, the project caters to 40-60 children, creating an optimal learning and nourishment environment. A key element of this project is the daily distribution of nutrient-enriched milk, containing essential vitamins and iron to support healthy growth. Hygiene is of utmost importance, and children are taught daily cleanliness practices, ensuring they arrive clean and tidy. The initiative provides uniforms and clothes to foster a sense of pride and belonging.

❖ Future Plan of Action

We strive to ensure the quality of life for quantity people by sustaining our environment, especially curbing carbon emissions, through the following developmental activities in the forthcoming years:-

- ➤ Strengthen People's Organization:Through capacity and skill development we aim to strengthen people's organizations including not only farmers but women and children also.
- ➤ Integrated Watershed Development:-

Organic Farm, Maximum vegetation Coverage, Rainwater Coverage, Pastureland & livestock management, Sericulture, Floriculture, Horticulture species and biomanufacturing, Biopesticide and insecticide, Fodder Species development, social and commercial forest development.

- ➤ Education and related activities.

 It includes education for nation-building in all manners.
- ➤ Development activities:-

Rampant Renewable Energy uses enhanced employment for a sustainable happy life in rural & poor sectors of society, mainstreaming Excluded & disadvantaged people.

Alternative Technologies for Building Construction Materials, and pastureland development carry out Health and development programs like Reproductive Child Health, Water and sanitation Research in different technologies on health, Environment, Livelihood and education.

Charities Aid Foundation of India (CAF) carried out a survey of 1342 NGOs from all over India including 113 NGOs from Bihar and Jharkhand combined. The evaluation of NGOs was done on the parameter of:

- Governance, Accountability and Transparency within Organization
